REQUIREMENTS 1 FULL CHARTER KMIA-SLVR service and cargo space/return flight (mandatory requirement for postulation). Cargo aircraft with a transport capacity of more than 40 tons (mandatory requirement for postulation). Aircraft with U.S. registration or Airline authorized to operate on the U.S.A.-South America route (mandatory requirement for postulation). 3 To have an Air Operator Certificate (AOC) (mandatory requirement for postulation). SERVICE TO BE PERFORMED Air transportation of bulky cargo, dangerous goods and general cargo, one (1) flight per week, on the following route: KMIA - SLVR, from 40 to 90 tons. 1.1 1.2 SLVR - KMIA, at TAB's request, approximately 20 tons. SERVICE PRICE PER FLIGHT THE PRICE SHALL INCLUDE: Aircraft, crew, maintenance, and insurance; Fuel and into-plane fueling charges for flight; Landing fees and navigational/overflight permits/fees; Aircraft handling, including Aircraft marshaling, air start, ground power units, pushback of Aircraft, stairs, and cleaning of Aircraft lavatories; Aircraft parking fees; Loading of cargo from the aircraft; Unloading of cargo from the aircraft; Pallets and Nets; Catering; Aircraft and Crew Security; US Customs AMS Processing. THE PRICE SHOULD NOT INCLUDE: The Charter Price does not include and Charterer shall be responsible to pay and arrange for the following services: Cargo handling (loading and unloading of cargo outside MIA); Pallet build (In & Out & breakdown in MIA and VVI); warehousing, transferring (including, delivery of cargo to Carrier's ramp), any special cargo handling (i.e. Crane and flatbeds, shoring), preparation of all cargo documentation, export permits and import permits, customs and agricultural clearances, all airport taxes, duties, and royalties, surcharges, and any other services, charges and/or fees not specifically included in the Charter Price. 3 Likewise, the price should not include the costs of loading and unloading cargo at the Viru Viru airport (SLVR). OTHERS The adjustment to the price of the service must be mentioned, based on the variation of the price of fuel in dollars per gallon (if applicable). WARRANTIES The warranty shall be governed by the laws of the carrier's country of origin. A. TERM OF SERVICE From the subscription of the contract until December 15, 2023. PAYMENT METHOD

C. CONFIDENTIALITY

Payment will be made by bank transfer prior to each flight (PrePayment).

The awarded bidder shall undertake to keep absolute confidentiality of the information to which it has access, or the information generated during the process of the aircraft rental service for cargo transportation.
